Testing has been completed on the SGI 3928 screen type spark arrester submitted for qualification testing. Reference the correspondence of November 6, 2003.

The SGI 3928 screen type spark arrester was examined and tested in accordance with the USDA Forest Service Standard 5100-1c, "Spark Arresters For Internal Combustion Engines." The SGI 3928 is qualified for an engine application of 39.7 horsepower, or smaller four-cycle engine. A flow rating of 162 cubic feet per minute has been assigned to this unit. A summary of the test results is attached. This unit will be listed in the Spark Arrester Guide as follows:
